RESEARCH RESEARCH INTERESTS

My current research interests focus on the interface between syntax and the morphogy/lexicon, as well as between syntax and Logical Form (LF). More precisely, the questions that interest me concern the nature of syntactic categories and their role in narrow syntax (as specific to the language faculty) and how the latter interacts with the interfaces. The empirical data come from the area of comparative but also diachronic syntax, as well as independent psycholinguistic research. Specific topics:

- a) Complementizers: their nature, properties and their position in the clause structure. The differences between complementizers and 'modal particles' (as is the case with the elements tha, na and as in Modern Greek; this particular topic is in joint work with A. Tsangalidis of the University of Thessaloniki). Implications for the articulation of the left periphery, their diachronic development ('grammaticalization', extending previous joint work with Ian Roberts of the University of Cambridge), and the question of s- and c-selection in the case of sentential complementation.
- b) Subjects: the role of the Extended Projection Principle (EPP) in the clause structure. Null subjects: the case of control (extending previous joint work with Rita M. Manzini of the University of Florence) and its manifestation in +/-finite contexts; subject extraction out of that-clauses the interaction of the syntactic subject with complementizers and particles. Derived subjects: passivisation and the role of morphology (especially in synthetic passives as in Greek and Albanian; current joint work with Rita Manzini).
- c) Wh-questions: moved and in-situ options; the relation between movement and interpretation.
